Enrico Reginato informed on his attendance of the EPHA meeting in Brussels, where the issue of health inequalities across Europe was tackled. On this occasion, he met the Commissioner-designate for Health. He also met EPHA president, Peggy Ryan with whom he raised the issue of Italian doctors.

Enrico Reginato insisted on FEMS having a strategy on health workforce; this was one main reason underlying FEMS application to the Joint Action on Health Workforce Planning and Forecasting; it is a project of the European Commission and FEMS participation to it will bring more visibility to FEMS goals and actions.

Concerning membership to EPHA, he informed that the – they are a big alliance, reuniting important names, so FEMS may have more direct contact to EU stakeholders by joining this alliance.

Stanislaw Urban informed about the actions taking place in the Poland on the occasion of the European Action Day 2014; the event was reflected more in the Polish media than by actual happenings and it achieved its purpose, namely that of informing people; OZZL made a letter to the Polish Minister of Health; nevertheless, he said that the collaboration with the ministry of health in Poland is inexistent since 5 years.

6 Report of the 1st Vice-President (P. Oravec)

Pavel Oravec said that there are quite a number of problems at the national level (Slovakia), especially regarding the public-private partnership (PPP). He insisted that the remuneration of doctors remains a problem. The law on doctors' remuneration is under attack by the government and politicians. He suggested that FEMS should have some direct connections at the level of European Parliament / European Commission so that it may put more pressure on the policy makers in Slovakia as well as to the benefit of other national organisations.

Enrico Reginato agreed that more lobbying is needed to have an impact on the European institutions.

Bojan Popovic said that FEMS primarily needs to have clear positions on various things, not only to react to what is happening; he said that in order to promote a successful lobby, FEMS must advance its own proposals. The EWTD may be one topic in point.

Enrico Reginato agreed on having a position on EWTD, as it concerns not only doctors but also other categories.

Pavel Oravec suggested further topics: doctors' working conditions, remuneration, collective bargaining and doctors' rights.

Enrico Reginato suggested that a list of topics should be drafted for what FEMS considers, for instance, to represent bad working conditions of doctors.

Bojan Popovic insisted that FEMS should be more aware of the problems at the national level.
